

THE CORPORATION OF THE TOWN OF THESSALON

BY-LAW NUMBER 1754

Being a by-law to establish a Municipal Marina/Lakeside Park Committee

**WHEREAS** Section 11 (1) of The Municipal Act, 2001, c.25, provides that a municipality may pass by-laws respecting matters within the “culture, parks, recreation and heritage” sphere of jurisdiction;

**THEREFORE** the Council of the Corporation of the Town of Thessalon hereby enacts as follows:

1. There is hereby established for the Town of Thessalon a Marina/Lakeside Park Committee, which shall be responsible for the development, as well as the operation and maintenance of the Marina and Lakeside Park facilities in accordance with the policies and procedures of the municipality.
2. The said Committee shall be known as the Marina/Lakeside Park Committee.
3. The Town of Thessalon Marina/Lakeside Park Committee shall consist of a maximum of five members. Two shall be members of the Town of Thessalon Municipal Council (to be appointed by the Council of the Town of Thessalon), and the remainder shall be residents of the Town of Thessalon (to be appointed by the Council of the Town of Thessalon).
4. The appointments to the Town of Thessalon Marina/Lakeside Park Committee shall be made annually in December or as soon thereafter as is expedient. The members shall hold office during the pleasure of the Municipal Council of the Town of Thessalon. On or before November 15th, the Committee shall advise Council in writing of the names of any persons who will not be serving on the Committee in the following year. When a vacancy occurs that creates a lack of quorum, an appointment will be made by Council as soon as possible.
5. DUTIES OF THE MARINA/LAKESIDE PARK COMMITTEE
  - a) The Committee shall encourage and assist with the operations of the Marina and Lakeside Park facilities.
  - b) The Committee shall assist, encourage and provide advisory services on request to all groups, organizations, or persons carrying on boating and camping activities in the Town of Thessalon.
  - c) The Committee shall at all times keep the inhabitants of the Town of Thessalon aware of the boating and camping opportunities which are available.
  - d) The Committee shall have the power to develop rules and regulations pertaining to the proper conduct of the community Marina and Lakeside Park programs, sanctioned by Municipal Council.
  - e) Annually, the Committee shall submit and interpret to the Municipal Council of the Town of Thessalon, a budget for its consideration and shall make to the Council full and complete reports as required.
  - f) In carrying out the provisions of the by-law, the Committee shall at all times be the agent of the Municipal Council of the Town of Thessalon and while acting bonafide within the limits of the authority of this by-law neither the Committee nor any member thereof shall incur any liability by reasons of anything done or left undone by the Committee provided, however, that nothing in this paragraph shall empower the Committee to incur any debt, liability or obligation for which the Municipal Council of

the Town of Thessalon shall become liable, without having previously obtained the written consent of the Municipal Council.

- g) Without limiting the generality of the foregoing, the Committee's authority shall include the Marina and Lakeside Park facilities, within the Town of Thessalon and responsibilities shall include all boating and camping programs and facilities.
6. That Town of Thessalon By-law Number 1465 is hereby repealed.
  7. That this by-law shall come into force and take effect immediately upon the final passing thereof.

Read a first and second time this 6<sup>th</sup> day of December, 2010.

Read a third time and finally passed this 6<sup>th</sup> day of December, 2010.
