CORRUGATED CARDBOARD

- * Layered cardboard boxes with ripple between layers
- * Place beside blue box flattened & bundled (30"x30"x8")

BOXBOARD

- * Cereal, detergent, shoe boxes etc. Remove liners.
- * Cardboard & boxboard Milk & Juice Cartons together

GLASS BOTTLES

- * Return BOTTLES to Beer Store
- NO GLASS PICKED UP**

METAL FOOD & BEVERAGE CONTAINERS

- * Metal & aluminum food & beverage cans
- * Aluminum foil trays
- * Rinsed jar lids can be placed with metal food cans

PLASTIC BOTTLES & JARS

- * Containers marked  through 
- * **NO styrofoam**
- * **NO grocery/garbage/milk/bread bags**
