First priority docking will be given to seasonal boaters from the previous year, if payment is received on or before May 31st.

Seasonal-Serviced and Non-Serviced Dockage

No refunds after July 31st under any circumstances.

The amount of the refund will be pro-rated in accordance to the seasonal serviced dockage rate for serviced or non-serviced and the number of days paid.

There will not be refunds for serviced or non-serviced monthly, weekly or daily dockage.

The refund will be subject to a 20% penalty.

For extended stays a credit card must be provided.
